Separate Sealed Bids for the construction of 2017 Sewer Rehabilitation consisting of the rehabilitation of approximately 12,000 LF of 8-inch, 10-inch and 12-inch sanitary sewers using pipe bursting, rehabilitation of approximately 70 manholes with cementitious lining, and sanitary sewer evaluation surveys (SSES) together with all related work as specified and shown on the Drawings will be received by the City of Crossville TN at the office of the City Clerk, 392 N Main Street, Crossville, TN 38555 until 2:00 PM April 18, 2017 (local time), and then at said office opened and publicly read aloud.

The allotted time for construction is 180 calendar days.

Digital copies of the bidding documents are available for \$25 per CD, after purchase of the printed bidding documents. Payment is **not refundable**. **Bids from anyone not on the Engineer's Plan Holders List will not be opened.**

Bids shall be accompanied by a bid bond or a certified check in an amount equal to five percent (5%) of the bid to insure the execution of the contract for which the bid is made. In case the bid is not accepted, the check or bid bond will be returned to the bidder, but if the bid is accepted and the bidder shall refuse or neglect to enter into a contract with the City of Crossville TN within ten (10) days after the time he has been notified of the acceptance of his bid, the said check or bid bond shall be forfeited to the City of Crossville TN as liquidated damages for the failure to do so.

No bidder may withdraw his bid for a period of ninety (90) days after closing time scheduled for the receipt of bids.

The City of Crossville TN reserves the right to waive informalities and to reject any and all bids.
