In submitting this bid, it is expressly agreed that upon proper acceptance by the City of Crossville of any or all items bid, a contract shall thereby be created with respect to the items accepted.

Bid Specifications for Roll Out Carts

Plastic Manufacturing Process and Materials:

The container shall be in full compliance with the American National Standard ANSI Z245.60. The bidder shall provide a compliance certification that the containers(s) provided to the City of Crossville meet the requirements of this standard.

The container shall have a minimum wall thickness of 0.175 inches throughout the body of the container. The container shall have a minimum wall thickness of 0.185 inches in the critical wear points (i.e., cart bottom, handle, lift mechanism).

INTERIOR CONSTRUCTION:

The interior surface shall be smooth and free from crevices, recesses, projections, and other obstructions where refuse could become entrapped.

DIMENSIONS:

The exterior dimensions (approximate) of the completely assembled container shall be as follows:

Height:	45 in.
Width:	28 in.
Length:	33 in.

COLOR:

Dark green

CAPACITY:

The container capacity shall be a minimum of 90 gallons. The container shall be capable of accommodating a load weighing up to 200 lbs. Please state exact capacity of container.

MOBILITY:

The container shall be designed with a molded in foot-operated tilt feature designed into the axle area to facilitate ease in tipping. Using the axle as fulcrum is unacceptable.

ABRASION PROTECTION:

The container shall be designed with a double drag rail on the container bottom with a minimum wall thickness of .185 inches.

WHEELS AND AXLE:

The wheel shall be a minimum of 12 inches in diameter. The axle shall be a minimum of 3/4 inches.

CONTAINER PICK UP POINTS:

The container shall be equipped with integrally molded pick up points. The semi-automated lifting area shall consist of 1" diameter free-floating steel bar at the lower attachment point.

ULTRAVIOLET INHIBITORS:

The container shall be stabilized against ultraviolet rays by an additive to the plastic resin of 2% by weight.

LID:

The container lid shall be manufactured in the same manner and from the same material as the container body and shall be of such a configuration that it will not warp, bend, slump, or distort to such an extent that it no longer fits the container properly or becomes otherwise unserviceable.

HANDLES:

Handle attachments must be an integrally molded part of the container body. Bolt-on handle mounts are unacceptable. Metal or exposed PVC pipe used as a handle is unacceptable.

IDENTIFICATION:

The container will be marked "PROPERTY OF THE CITY OF CROSSVILLE" on the lid, with consecutive serial numbers on the exterior, visible from the front of the container. These markings will be hot-stamped into, or otherwise permanently fixed, on the containers, and will be a different color than the container. Painted-on markings will be unacceptable.

DELIVERY

Bids will be for containers to be delivered FOB to the City of Crossville, Public Works Compound.

WARRANTY

Send warranty information with bid.

Bid prices should reflect the cost of any and all hardware necessary to assemble the containers.

Carts will be purchased in quantities of 100 for this contract period.**

IRAN DIVESTMENT ACT

A bid shall not be considered for award nor shall any award be made where the foregoing certification has not been complied with; provided, however, that if in any case the bidder cannot make the foregoing certification, the bidder shall so state and shall furnish with the bid a signed statement which sets forth in detail the reasons therefor. The City of Crossville may award a bid to a bidder who cannot make the certification, on a case-by-case basis, if:

- (1) The investment activities in Iran were made before July 1, 2016, the investment activities in Iran have not been expanded or renewed on or after July 1, 2016, and the person has adopted, publicized, and is implementing a formal plan to cease the investment activities in Iran and to refrain from engaging in any new investments in Iran; or
- (2) The City of Crossville makes a determination that the goods or services are necessary for the City of Crossville to perform its functions and that, absent such an exemption, the political subdivision will be unable to obtain the goods or services for which the contract is offered. Such determination shall be made in writing and shall be a public document.
