The City of Crossville is requesting proposals for Construction Services for a proposed Box Hangar at Crossville Memorial Airport. Proposals will be received by the <u>City of Crossville</u> at <u>392 North Main St., Crossville, Tn 38555</u> at the office of <u>City Clerk</u> until <u>10:00</u> o'clock A.M., C.D.T. <u>July 7, 2023</u>. All proposals should be properly marked **CITY CLERK/RFP** and "**RFP** – **Construction Services – Box Hangar**" on the outside of the envelope. No electronic submissions accepted.

Scope of Services

The proposed project for construction includes a pre-engineered metal building with a Box Hangar Area being 80 feet by 80 feet and an Office Area being 12 feet by 80 feet. The new facility shall meet or exceed the local and the state building codes. See attached Minimum Requirements and Concept Plan for more information.

Services to be included are as follows:

- Provide the City with a contract that meets all requirements of this project.
- Attend and coordinate a kick-off meeting with City Staff in order to clarify the City's requirements for the project.
- The Contractor shall provide all architectural and engineering services required to obtain a building permit.
- The Contractor shall construct the building on a pad ready site at the airport.
- Proposal to included a schedule for the project based upon the scope of services.
- Proposal to include a lump sum price based upon the scope of services and list of any allowances used in the proposal that is included in the lump sum price.

General Building Requirements:

Red Iron Construction for all exterior walls. Primary-Frame Type: Rigid Clear Span: Solidmember, structural-framing system without interior columns Secondary-Frame Type: Manufacturer's standard purlins and joists and flush-framed girts. Shop drawings to be approved by the city.

Minimum wall sheeting to be 26 gauge, and a minimum roof sheeting to be 24 gauge with a 30-year warranty.

Roof areas to have a minimum 1:12 pitch for Box Hangar Area. Office Area may have a steeper pitch.

Standing seam roof.

Minimum Insulation requirement shall be Faced Metal Building Insulation: ASTM C 991, Type II, glass-fiber-blanket insulation; 0.5-lb/cu.ft. (8-kg/cu. m) density; Minimum thickness 6-inch R-19.

Concrete floor thickness 6 inches with 6x6 Mesh w2.9xw2.9 reinforcing and 10 mil polyethylene vapor barrier.

Three 36-inch walk through doors on the front and rear wall with minimum 5 foot by 5 foot concrete pad. One of the doors can be in the Hangar Door. Doors to be in a manner so that the egress will be a maximum of 75 feet.

Hangar Door to be a one-way Horizontal Rolling Door with a pocket outside the building envelope for receiving the door. Hangar door clear opening to be 24 feet high and 70 feet long. Hangar Door to be motorized.

A minimum two-foot concrete strip around the perimeter of the building

All gutter downspouts shall be tied to underground stormwater system. 8" downspout leaders and a 12" inch roof drain from the downspout leaders to the stormwater system.

The building design and construction shall be in strict accordance with the latest applicable codes and standards.

TEMPORARY FACILITIES

The Contractor shall provide a temporary field office, sanitation facilities and equipment required during the duration of the project. The Contractor shall provide a dumpster as required for the project. The Owner shall provide and be responsible for temporary electrical, gas and water services while the work is in progress.

The Contractor is responsible for building permit, and the City of Crossville is responsible for building permit fee in this proposal.

The Contractor shall provide all architectural and engineering services required to obtain a building permit and to clearly indicate the scope of work to the Owner. The Contractor understands that all Civil Site Design will be completed by the City of Crossville. City to review all shop drawings.

Qualifications: The Contractor shall have experience in the design and construction of aviation facilities, and shall meet the following as a minimum:

- A) Business license for the City of Crossville and/or Cumberland County.
- B) Contractor to utilize an architectural design service with at least (1) TN licensed professional(s).
- C) An unlimited, licensed General Contractor in the State of TN.
- D) At least three (3) aviation related facilities constructed in TN in the last ten years
- E) Ability to provide a performance and payment bond for entirety of the project.

The Contractor shall carry all necessary workman's compensation, builder's risk, and following liability insurance with the below minimum limits:

General liability:	\$ 5,000,000
Automobile Liability:	\$ 1,000,000
Excess Liability:	\$ 2,000,000
Worker's Compensation:	\$ 1,000,000

The Contractor shall provide an onsite Field Manager, Project Manager, and office support as required to manage the project.

The Contractor shall prepare and update a monthly construction schedule.

The Contractor shall provide daily cleanup as needed throughout the duration of the project and final cleanup.

The Contractor shall coordinate all project meetings, processing of subcontractor's submittals, contract close-out and facility startup.

The Contractor to provide a project schedule with his proposal.

Start date to be no more than 45 days after the award.

Completion date no more than 180 days after the Notice to Proceed.
